### MINUTES OF MEETING OF BOARD OF DIRECTORS

All members of the Board were present, with the exception of Director Bethany, thus constituting a quorum. Also attending all or portions of the meeting were: Tina Buchanan of Equi-Tax, Inc., tax assessor-collector and bookkeeper for the District ("Equi-Tax"); David Niccum; Mike Kiger; William (Bill) Judice; Mark Wells; and Chris Paddack, residents of the District.

The President, after finding that notice of the meeting was posted as required by law and determining that a quorum of the Board was present, called the meeting to order and declared it open for such business as may regularly come before it.

1. <u>Bookkeeper's Report/Investment Report/Tax Assessor-Collector's Report/Energy Usage</u> <u>Report</u>. Ms. Buchanan presented to and reviewed with the Board, the Bookkeeper's Report, Investment Report, Tax Assessor-Collector's Report, and Energy Usage Report for the previous month, copies of which are attached hereto collectively as <u>Exhibit "A."</u>
