#### Summary of Events

##### Criminal Mischief:

19500 Whitewood Dr– Complainant reported damage to the residence’s door. It is unknown when the damaged occurred. There are no suspects at this time.

##### Family Assault:

400 Dover Ln: Deputies responded to a family disturbance where the complaint reported that she was assaulted by known family member. The Harris County District Attorney Office was contacted and declined charges. Both parties were separated without further incident.

600 Turley- Deputies responded to a family disturbances. Upon investigation it was found that one party had assaulted the other. The Harris County District Attorney Office was contacted and accepted the charge of family assault. The suspect was placed into custody and booked into the Harris County Jail.

ALARMS – Contract patrol deputies responded to 3 local alarms at various locations within the community. They were handled without incident and were all found to be false alarms.

MUD CHECKS – Contract patrol deputies made 59 Municipal Utility Checks within the community. There were no signs of foul play and all facilities appeared to be in good working order.

OTHER CALLS - Contract and District patrol deputies responded 68 to other calls for service within the community, while maintaining peace and justice in the contracts.

SUSPICIOUS VEHICLES – Contract patrol deputies responded to 3 suspicious vehicles within the community. All these scenes were utilized to gather intelligence and were all cleared without incident after thorough investigations.

TRAFFIC – Contract patrol deputies made 75 traffic stops, enforcing the traffic laws of the state of Texas, within the contract reducing the possibility of accidents and lessening the chance of repeat offenders in the patrolled areas.
