ALARMS – Contract patrol deputies responded to 2 local alarms at various locations within the community. They were handled without incident and were all found to be false alarms.

OTHER CALLS - Contract and District patrol deputies responded 34 to other calls for service within the community, while maintaining peace and justice in the contracts.

SUSPICIOUS VEHICLES – Contract patrol deputies responded to multiple suspicious vehicles within the community. All these scenes were utilized to gather intelligence and were all cleared without incident after thorough investigations.

TRAFFIC – Contract patrol deputies made 179 traffic stops, enforcing the traffic laws of the state of Texas, within the contract reducing the possibility of accidents and lessening the chance of repeat offenders in the patrolled areas.
