Summary of Events

Aggravated Family Assault

19500 Lockridge - Complainant was assaulted with a weapon by a known family member. The known family member was taken into custody and booked into Harris County Jail for aggravated assault.

Burglary of a Motor Vehicle-

19500 Whitewood Dr- A male suspect made unauthorized entry into the complaint's vehicle and stole property from within the vehicle.

Transportation Code Violation:

19300 Lockridge Dr- A traffic stop was conducted for a transportation code violation. The driver was found have multiple open misdemeanor warrants. The driver was taken into custody for the warrant and booked into the Harris County Jail.

19200 Lockridge Dr- A traffic stop was conducted for a transportation code violation. The driver was found have multiple open misdemeanor warrants. The driver was taken into custody for the warrant and booked into the Harris County Jail.

Disturbance Other:

400 Bickett Ln – Two neighbors had a verbal argument over a civil matter. During the course of the argument a dog bite was reported. The dog bite was referred to animal control.

1100 Lynwood Rd – Complainant requested a report to document a civil dispute with a contractor.

ALARMS – Contract patrol deputies responded to 3 local alarms at various locations within the community. They were handled without incident and were all found to be false alarms.

MUD CHECKS – Contract patrol deputies made 56 Municipal Utility Checks within the community. There were no signs of foul play and all facilities appeared to be in good working order.

OTHER CALLS - Contract and District patrol deputies responded to 56 other calls for service within the community, while maintaining peace and justice in the contracts.

SUSPICIOUS ACTIVITY – Contract patrol deputies responded to 5 suspicious vehicles and 3 suspicious person within the community. All these scenes were utilized to gather intelligence and were all cleared without incident after thorough investigations.

TRAFFIC – Contract patrol deputies made 27 traffic stops, enforcing the traffic laws of the state of Texas, within the contract reducing the possibility of accidents and lessening the chance of repeat offenders in the patrolled areas.
