Summary of Events

Burglary of a Motor Vehicle:

200 E North Hill – A contractor left his vehicle unoccupied while working in the area. Upon returning to the area an unknown suspect(s) forced entry and stole property from within the truck.

Family Assault:

1300 Lemm Rd #2 – The complainant she was in a dating relationship with a known person and that the known person threatened her with a firearm. The actual offense took place outside of the neighborhood at an unknown location. The suspect was located and arrested for aggravated assault.

600 E Cypresswood Dr- Two adult brother were involved in a physical altercation. Upon investigation the Harris County DA's Office was contacted declined to accept charges at this time. The two were separated for the night.

Transportation Code Violation:

18600 Casper Dr: A traffic stop was conducted on two vehicles. Upon further investigation it was found that neither vehicle had a license driver or insurance. The vehicles were towed and the drivers were cited.

Other:

200 Bickett Ln: A male requested a report to document a civil dispute with a contractor.

ALARMS – Contract patrol deputies responded to 1 local alarm within the community. The alarm was handled without incident and was found to be false alarm.

MUD CHECKS – Contract patrol deputies made 30 Municipal Utility Checks within the community. There were no signs of foul play and all facilities appeared to be in good working order.

OTHER CALLS - Contract and District patrol deputies responded 52 to other calls for service within the community, while maintaining peace and justice in the contracts.

SUSPICIOUS VEHICLES – Contract patrol deputies responded to 4 suspicious vehicles within the community. All these scenes were utilized to gather intelligence and were all cleared without incident after thorough investigations.

SUSPICIOUS PERSONS – Contract patrol deputies responded to 2 suspicious persons within the community. All these scenes were utilized to gather intelligence and were all cleared without incident after thorough investigations.

TRAFFIC – Contract patrol deputies made 42 traffic stops, enforcing the traffic laws of the state of Texas, within the contract reducing the possibility of accidents and lessening the chance of repeat offenders in the patrolled areas.
