Summary of Events

October Stats

Burglary of a Motor Vehicle:

19500 Whitewood Dr – The Complainant reported that an unknown subject made unauthorized entry into his unlocked vehicle and stole property.

19300 Whitewood Dr -The Complainant reported that an unknown subject made unauthorized entry into his open vehicle and stole property.

Fraud:

19100 Whitewood Dr - The complainant reported that an unknown person had used their information at open an account in their name.

600 Turley – The complainant reported that an unknown person had stolen a check from the mail and altered the check. The postal police was notified.

Transportation Code Violation:

600 E Cypresswood – A traffic stop was conducted on a vehicle for speeding. Upon making

contact with the driver It was found that they did not have a license or insurance. The vehicle was towed and the driver was cited.

Family Disturbance:

18700 Casper Dr – Known family members were involved in a verbal altercation. No criminal offense occurred. The parties were separated for the evening.

Failure to Stop and Give Information (FSGI):

700 E Cypresswood Dr – The complainant was involved in a minor accident. The other driver fled the scene without stopping to exchange information.

ALARMS – Contract patrol deputies responded to 4 local alarms at various locations within the community. They were handled without incident and were all found to be false alarms.

MUD CHECKS – Contract patrol deputies made 26 Municipal Utility Checks within the community. There were no signs of foul play and all facilities appeared to be in good working order.

OTHER CALLS - Contract and District patrol deputies responded 35 to other calls for service within the community, while maintaining peace and justice in the contracts.

SUSPICIOUS VEHICLES – Contract patrol deputies responded to 4 suspicious vehicles within the community. All these scenes were utilized to gather intelligence and were all cleared without incident after thorough investigations.

TRAFFIC – Contract patrol deputies made 61 traffic stops, enforcing the traffic laws of the state of Texas, within the contract reducing the possibility of accidents and lessening the chance of repeat offenders in the patrolled areas.
