Summary of Events

Criminal Mischief:

1300 Lynwood Dr – The complainant reported that an unknown subject(s) caused damage to his unoccupied vehicle.

Death Investigation:

Terroristic Threat:

Transportation Code Violation:

600 E Cypresswood Dr- A traffic stop was conducted for a vehicle speeding in a school zone. It was found that the driver was in possession of forged registration sticker. The driver was cited for 3 traffic violations and released pending further investigation of the sticker.

Stolen Vehicle:

Illegally Dumping:
