Summary of Events

Criminal Mischief:

300 E North Hill Dr- An unknown subject caused minor damage to the complainant's vehicle. There is no suspect information at this time.

Fraudulent use of Id:

19400 Whitewood- The complainant reported that an unknown subject opened accounts in the complainant's name.

Family Disturbance:

1300 Lemm Rd #2 – Known family members had a verbal argument. Deputies were able to separate parties without incident.

Animal Humane:

Bickett Ln/ Kelly St – Deputies were notified of an improperly disposed dead dog. Due to the suspicious nature, the incident was referred over to the Harris County Animal Cruelty task force.

Accident:

600 E Cypresswood- Deputies responded to a two vehicle minor accident. There were no injuries reported.

18900 North Freeway/ E North Hill – Deputies were dispatched to a two vehicle major accident.

Upon arrival it was found that there were no major injuries. The at fault driver was found to have 21 open warrants and was taken into custody/

ALARMS – Contract patrol deputies responded to 0 local alarms.

MUD CHECKS – Contract patrol deputies made 61 Municipal Utility Checks within the community. There were no signs of foul play and all facilities appeared to be in good working order.

OTHER CALLS - Contract and District patrol deputies responded to 39 other calls for service within the community, while maintaining peace and justice in the contracts.

SUSPICIOUS VEHICLES – Contract patrol deputies responded to 3 suspicious vehicles within the community. All these scenes were utilized to gather intelligence and were all cleared without incident after thorough investigations.

TRAFFIC – Contract patrol deputies made 60 traffic stops, enforcing the traffic laws of the state of Texas, within the contract reducing the possibility of accidents and lessening the chance of repeat offenders in the patrolled areas.
