Summary of Events

Burglary of A Motor Vehicle- 19100 E Challe – The complainant reported that an unknown subject had stolen property from his unlocked vehicle. There was no witnesses and no video footage.

FAMILY DIST. – 19100 E Challe - Contract patrol deputies responded to family type disturbances within the contract. No criminal offense occurred. Parties were separated without further incident.

TRAFFIC - Contract patrol deputies made 52 traffic stops, enforcing the traffic laws of the state of Texas, within the contract reducing the possibility of accidents and lessening the chance of repeat offenders in the patrolled areas.

ALARMS - Contract patrol deputies responded to 4 local alarms at various locations within the community. They were handled without incident and were all found to be false alarms.
