Summary of Events

Assault- 19503 Barwick Dr.- A solicitor went to Station 8 to make a walk-in report for an assault. The solicitor stated that he was on the homeowner's property, when the homeowner returned home grabbed him by the shirt. The solicitor left the station before the interview was complete, no charges were filed.

Evading- 19319 Casper Dr.- The Harris County Sheriff Department was pursuing a felony suspect that came into the contracted area. Contract Deputy assisted with arresting the suspect.

Vehicle Recovery- 19011 Whitewood Dr.- A female suspect from the City of Houston took her mother's vehicle, without her permission and drove to the contracted area to visit her aunt. The vehicle was tracked to the listed location and recovered by contract deputy.

Disturbance Family- 19011 Whitewood Dr. The complainant stated that her niece was being disrespectful and she wanted her to leave. The complainant's niece left the location. No crimes were committed.

Other Calls- Contract and District Patrol Deputies responded to 47 other calls for service within the community, while maintaining peace and justice in the contract.

MUD Checks- Contract and District Patrol Deputies made 26 Municipal Utility Checks within the community. There were no signs of foul play, and all facilities appeared to be in good working

order.

Traffic- Contract Patrol Deputies made 43 traffic stops, enforcing the traffic laws of the State of Texas, within the contract reducing the possibility of accidents and lessening the chances of repeat offenders in the patrolled areas.
