Mental Health Call:

Mental Health Call:

700 block of E Cypresswood Dr- The complainant wrote a goodbye text and sent it to her family members and friend, threatening to jump off a bridge. The complainant was transported to the hospital and accepted on an Emergency Detention Order.

Theft:

18900 block of the North Fwy- The complainant stated that a b/m suspect stole scrap metal from the back of the business.

Assault:

700 block of E Cypresswood Dr- The complainant stated that she was assaulted by her cousin's boyfriend, but she refused to cooperate with the investigation. The District Attorney decline to accept charges.

Suspicious:

19200 block of Tyrone St- The complainant called in a suspicious person driving a white Kia Soul. The suspicious person asked the complainant for some water and to use their restroom. The complainant refused and asked the suspect to leave. Deputies found the suspect and vehicle on Lynwood Rd. and determined that the suspect suffered from mental illness.

Drug Overdose Possession:

700 block of E Cypresswood Dr- The complainant was trying to harm herself by overdosing on pills. The complainant was transported to the hospital and accepted on an Emergency Detention Order.

Suspicious Activity:

400 block of Bickett Ln- Deputies responded to a homeowner stating that an occupied U-Haul Truck was parked in her driveway. The complainant stated that her husband made contact with the b/m occupant who fled the location on foot. Deputies searched the area for the suspect but did not find him. The U-Haul Truck was towed from the complainants driveway.

Traffic Stop:

E Cypresswood Dr/Lockridge Dr- A traffic stop was conducted and it was discovered that the driver had outstanding warrants. The driver was arrest for outstanding warrants and unlawful carry of a firearm.

Vehicle Stolen:

700 block of E Cypresswood Dr- The complainant stated that his vehicle was stolen from the apartment complex and had a firearm inside of the vehicle.

Vehicle Recovery:

700 block of E Cypresswood Dr- An unoccupied stolen vehicle out of the Houston Police Department was recovered from the apartment complex.

Harassment:

Illegal Dumping:

MUD Checks:
