Summary of Events

Home Invasion:

700 block of E Cypresswood Dr -Evening Shift- The complainant stated that four suspects forced their way into his apartment. Three of the suspects were wearing masks. The complainant was pistol wiped; cash and other properties were stolen. Two of the suspects were identified and charged.

Criminal Mischief:

700 block of E Cypresswood Dr -Dayshift- The complainant stated that an unknown suspect broke the window out of her vehicle.

Theft from Motor Vehicle:

19000 block of Casper Dr -Day Shift- The complainant stated that the tailgate was stolen off his pickup truck. Theres no suspect information or evidence.

Assault:

700 block of E. Cypresswood Dr -Evening Shift- The caller stated that her child was hit in the head with a rock by another child who lives in the apartment complex. The caller did not wish to pursue

charges, and the suspect was too young to be charged.

Death Investigation

200 block of E. North Hill Dr -Dayshift- Deputies worked a death investigation call.

Suspicious Activity

600 block of E Cypresswood Dr -Nightshift- The callers pet cat was attacked by the neighbors 2 Pit Bull Dogs. The callers cat sustained serious injuries and was taken to a veterinarian.

Suspicious Activity

18800 block of Whitewood Dr -Evening Shift- The suspect was at his ex-wifes residence trying to change the locks and stating that he had power of attorney of her because she was ill. The suspects power of attorney had been voided, and the locks were not changed.

Stolen Vehicle:

700 E Cypresswood Dr -Nightshift- The complainant stated that 2 suspects stole her vehicle from the apartments parking lot about 3:00 am. There is video footage of the incident. The investigation is ongoing.

Domestic Disturbance-No Assault:

700 block of E Cypresswood Dr -Dayshift- The complainant stated she was having a verbal argument with the father of her child. There were no threats or assault.

MUD Checks:

Contract Patrol Deputies made 30 Municipal Utility checks within the community. There were no signs of foul play, and all the facilities appeared to be in good working order.
