Burglary Motor Vehicle:

Identity Theft:

700 block of E Cypresswood Dr- Dayshift- The reportee stated that her brother who suffers from autism, and his friend opened a checking account in his name.

Phone Harassment:

700 block of E Cypresswood Dr- Dayshift- The complainant stated that the father of her children is contacting her for visitation. The complainant stated that she recently moved from out of state, and she does not know how he found her. The complainant requested a report.

Accidental Injury:

700 block of E Cypresswood Dr- Evening Shift- A family was at the pool having a BBQ, when a mother took the floaties off of her 4-year-old daughter to feed her. The mother turned her back to prepare the food, and the child jumped in the pool. The child was found floating in the pool and was resuscitated.

MUD Checks:
