Summary of Events

Criminal Mischief:

400 block of Bickett Ln- Evening Shift- The complainants mailbox was damaged by an unknown suspect. Theres no evidence at this time.

Criminal Mischief:

700 block of E Cypresswood Dr -Night Shift- 2 female suspects damaged a vehicle in the apartment parking lot. There were multiply witnesses. Deputies were able to locate the suspects and charges were accepted. The suspects were arrested.

Criminal Mischief:

19500 block of Lockridge Dr -Night Shift- Deputies were dispatched to a criminal mischief call. 4 suspects fled the location on foot and ran through the community.

Criminal Mischief:

700 block of E Cypresswood Dr- Dayshift- The complainant stated that an unknown suspect slashed the tires and broke the windows out his vehicle in the apartment parking lot.

Assault Sexual:

19100 block of E Challe Cir- Dayshift- Deputies were dispatched to a sexual assault call. The district attorney was contacted, and charges were accepted.

Assault:

700 block of E Cypresswood Dr- Evening Shift- The reportee stated that her son was assaulted by an Indian male suspect in the gym at the apartment complex. The investigation is ongoing.

Terroristic Threat:

700 block of E Cypresswood Dr- Nightshift- The complainant stated that she has been receiving threatening calls and text messages from her ex-boyfriend. The case was referred for further investigation.

Disturbance Family:

700 block of E Cypresswood Dr- Dayshift- The reportee stated that her boyfriend is being violent with her son, and she is in fear of her life.

Warrant Service:

1200 block of Lynwood Rd- Nightshift- Deputy executed an outer county warrant. The suspect was arrested and booked on for multiple warrants

Accident:

700 block of E Cypresswood- Evening shift- Deputy on-viewed a 1 car minor accident in the apartment parking lot. The driver lost control of his vehicle and struck a light pole as he attempted exit the complex.
