Summary of Events

Assault Family:

700 block of E Cypresswood Dr -Evening Shift- Deputies were dispatched to a family violence call. 1 suspect was arrest for family violence assault impeding breathe. The suspect also had a warrant out for his arrest.

Assault Family:

700 block of E. Cypresswood Dr -Dayshift- The complainant stated that he was assaulted by his ex-girlfriend. The district attorney accepted assault charges.

Suspicious Person:

700 block of E Cypresswood Dr- Dayshift- The complainant stated that an unknow person attempted to gain entry into her apartment by turning on the doorknob. The complainant yelled that she had a gun, and the suspect fled the location in an unknown direction.

Runaway:

700 block of E Cypresswood Dr -Evening Shift- The reportee stated that her 16-year-old daughter ran away from home after she was suspended from school. Deputy completed a missing persons report and later found the runaway at her boyfriends house.

Evading Arrest and Detention:
